## Prior Experience

## Representative Matters

- In a complex real estate partition and partnership dispute, we secured a full-value buyout for our client through strategic negotiation. By resolving the matter pre-litigation, we delivered the client's desired financial outcome while avoiding the cost, delay, and risk of court proceedings.
- Settled a significant six-figure pre-suit demand for just 6.4% of the initial claim on behalf of a client involved in a services agreement dispute with a digital content and media company.
